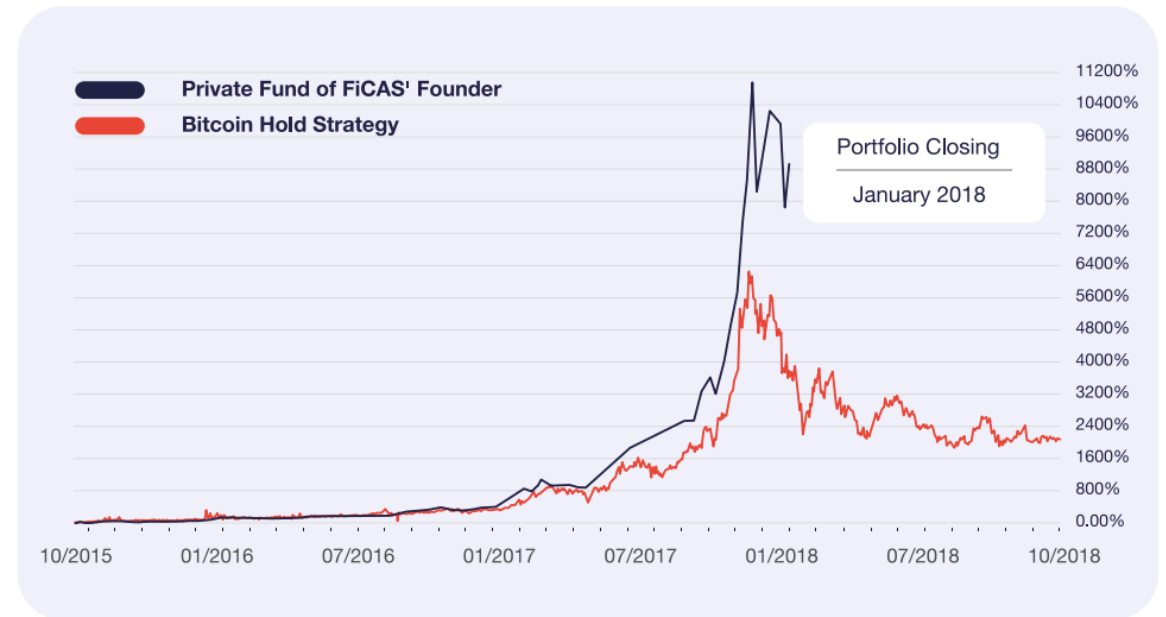

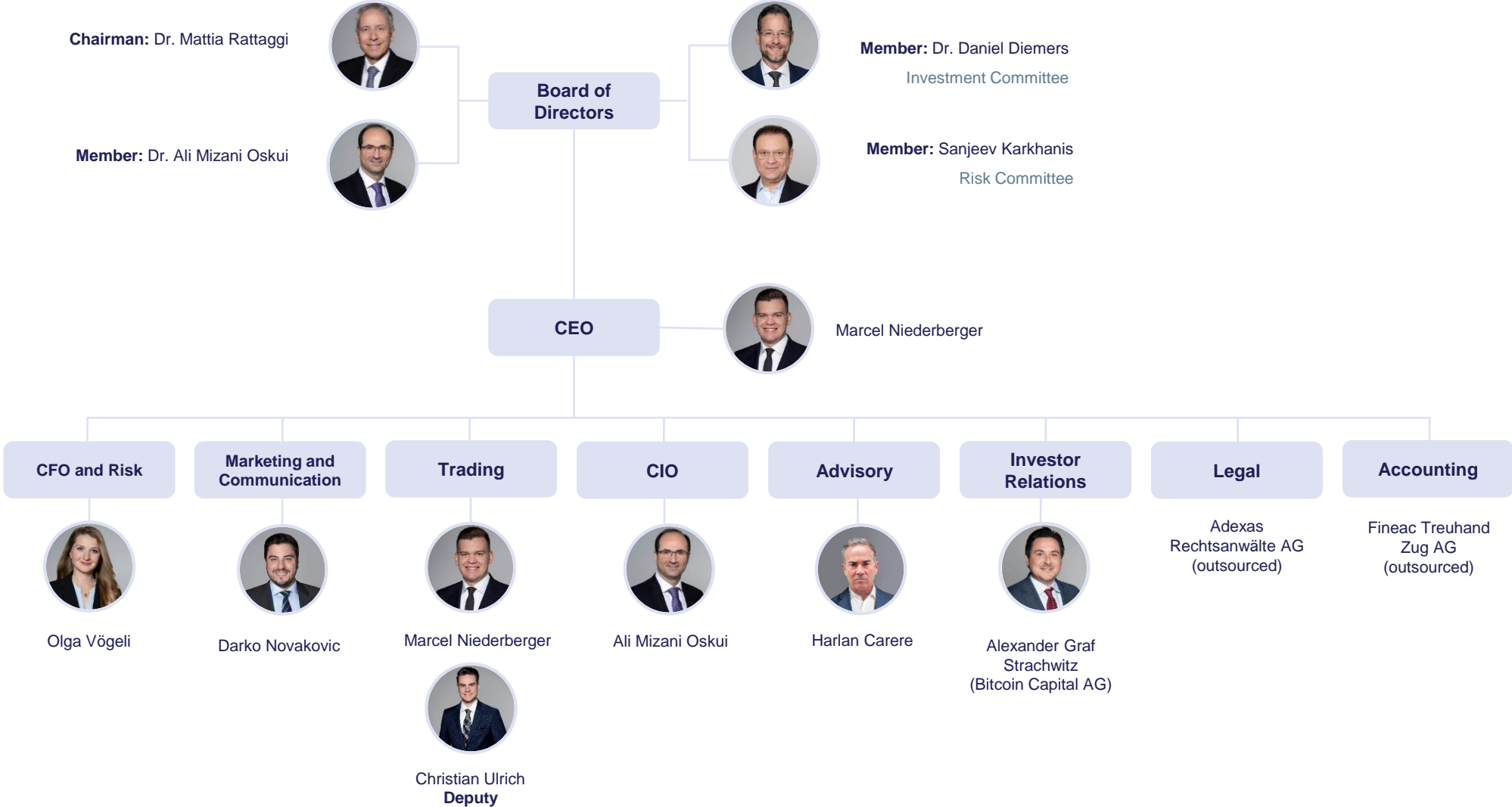

Key indicators and parameters:

- Active addresses, mining cost, transactions, circulating supply, regulatory aspects (including anonymity), network difficulty, storage ability.
- Solidity of underlying business, exchanges supporting the coin.
- Market-wide aspects: coins correlations, market cap ranking, dominance.
- Technical analysis (Chartism), macro views / seasonality, relative values (dynamic).

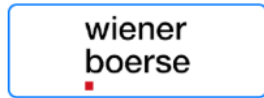
